BAC RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of TSU Vehicles with an Approved Budget for the Contract (ABC) of ₱ 15,030,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on August 21, 2024;

WHEREAS, in response to the Invitation to Bid, five prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University BAC Conference Room and webcasted via Zoom on August 29, 2024;

WHEREAS, in the public bidding held at the TSU-BAC Conference Room on September 11, 2024, at 2:00 P.M.:

- (a) Two bidders, namely, Toyota Tarlac City, and B.M. Domingo Motor Sales Inc., tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelope contained in the bid submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found that the first envelope of B.M. Domingo Motor Sales Inc., contained all the required documents and was rated "passed", while Toyota Tarlac City was found to be "ineligible" on the ground that its Omnibus Sworn Statement was incomplete; specifically due to omission of clause no. 10;
- (c) the BAC with the assistance of the TWGs, then opened and checked the second envelope contained in the bid of the lone bidder and found that the second envelope contained the prescribed documents and was rated "passed"
- (d) the BAC resolved to declare B.M. Domingo Motor Sales Inc., as the bidder with the Single Calculated Bid for Lot No. 1 with an amount of 3,790,000.00,
- (e) the BAC directed the TWGs to proceed with the Post-Qualification Evaluation of the Single Calculated Bid for Lot No. 1 and report their findings to the BAC within the prescribed period,
- (f) the BAC declared a Failure of Bidding for Lot No. 2 and 3, since no bid was received,
- (g) the BAC direct the BAC Secretariat to post the re-bidding for Lot No. 2 and 3 for the aforementioned project in accordance with Section 35.3 of the IRR of R. A. 9184.

WHEREAS, in the Post-Qualification Evaluation Conference held via Zoom on October 8, 2024:

- (a) the TWG for Financial and Legal Aspects reported that the Single Calculated Bid for Lot no. 1 was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the Single Calculated Bid for Lot no. 1 was responsive to the technical requirements for the project as prescribed in the Bidding Documents,
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the Single Calculated Bid for Lot no. 1 as responsive;

THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- (a) to declare B.M. Domingo Motor Sales Inc., as the bidder with the Single Calculated and Responsive Bid (SCRB) for Lot No. 1, with the bid price of Three Million Seven Hundred Ninety Thousand Pesos (3,790,000.00), and
- (b) to recommend to the President the Award of Contract for Lot no. 1 of the project, Supply and Delivery of TSU Vehicles to B.M. Domingo Motor Sales Inc.

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of TSU Vehicles with an Approved Budget for the Contract (ABC) of ₱ 15,030,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous places in Tarlac State University on August 21, 2024;

WHEREAS, in response to the Invitation to Bid, five prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University BAC Conference Room and webcasted via Zoom on August 29, 2024;

WHEREAS, in the public bidding held at the TSU BAC Conference Room and webcasted via Zoom on September 11, 2024, at 2:00 P.M., two bidders, namely, Toyota Tarlac City, and Isuzu BM Domingo Motor Sales Inc., participated and tendered a bid for the aforementioned project;

WHEREAS, the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and evaluated the first envelope contained in the bid submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found that the first envelope of Isuzu BM Domingo Motor Sales Inc., contained all the required documents and was rated "passed", while Toyota Tarlac City was found to be "ineligible" on the ground that its Omnibus Sworn Statement was incomplete; specifically due to omission of clause no. 10;

WHEREAS, the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelope of the lone bidder and found that the envelope of the lone bidder contained the prescribed documents and was rated "passed";

WHEREAS, the BAC with the assistance of the TWGs, proceeded with the evaluation of the financial bid of the lone bidder with the result as summarized below:

- c. to declare a Failure of Bidding for Lot No. 2 and 3, in as much as no bid was received,
- a. to direct the BAC Secretariat to post the re-bidding for Lot No. 2 and 3 for the aforementioned project in accordance with Section 35.3 of the IRR of R. A. 9184.
