WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply, Delivery, and Installation of Furniture for the College of Teacher Education with an Approved Budget for the Contract (ABC) of ₱ 1,793,730.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on February 10, 2023;

WHEREAS, in response to the Invitation to Bid, five (5) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on February 16, 2023;

WHEREAS, in the public bidding held at the Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on February 28, 2023, at 2:00 P.M.:

- (a) two bidders, namely, Vitara Marketing, and NSB Engineering Design & Fabrication, tendered bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found the first envelopes of the two bidders to contain all the required documents and were rated "passed",
- (c) the BAC, with the assistance of the TWGs, evaluated and ranked the bids of the two bidders whose first envelopes were rated "passed",
- (d) the BAC resolved to declare Vitara Marketing as the bidder with the Lowest Calculated Bid (LCB) with the bid price of ₱ 1,477,000.00, and
- (e) the BAC directed the TWGs to proceed with the post-qualification evaluation of the LCB;

WHEREAS, in the Post-Qualification Evaluation Conference held at the Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on May 2, 2023:

(a) the TWG for the Legal and Financial Aspects reported that the LCB failed to include in their List of All On-going Government and Private Contracts, Including Contracts Awarded But Not Yet Started namely, Supply and Delivery of Furniture and Fixture for Various Schools in Muntinlupa as required in the

Bidding Documents. Also, the LCB failed to update the Certificate of PhilGEPS Registration in their Bid, in accordance with GPPB Resolution No. 15-2021

- (b) the BAC directed the TWGs to proceed with the post-qualification evaluation of the bid of NSB Engineering Design & Fabrication, the second Lowest Calculated Bid. and
- (c) the BAC directed the Secretariat to issue the Notice of Disqualification to Vitara Marketing.

WHEREAS, in the Post-Qualification Evaluation Conference held at the Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on May 18, 2023:

- (a) the TWG for the Legal and Financial Aspects reported that the 2nd LCB was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the 2nd LCB was responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare that the 2nd LCB as responsive;

THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- (a) to declare the bid of NSB Engineering Design & Fabrication as the Lowest Calculated and Responsive Bid with the bid price of ₱ 1,722,960.00 and
- (b) to recommend to the President the Award of Contract for the project Supply, Delivery, and Installation of Furniture for the College of Teacher Education to NSB Engineering Design & Fabrication.
