APPROVED BUDGET FOR THE CONTRACT (ABC): 1,000,000.00

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Instructional Accounting Software for the College of Business and Accountancy (APP 2024) with an Approved Budget for the Contract (ABC) of ₱ 1,000,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on September 27, 2024;

WHEREAS, in response to the Invitation to Bid, four (4) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University BAC Conference Room and webcasted via Zoom on October 8, 2024;

WHEREAS, in the public bidding held at the TSU-BAC Conference Room on October 22, 2024, at 3:00 P.M.:

- (a) One bidder, namely, Datacore Technologies Inc., tendered a bid for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelope contained in the bid submitted by the lone bidder, using the non-discretionary "pass/fail" criterion, and found that the first envelope contained all the required documents and was rated "passed";
- (c) the BAC with the assistance of the TWGs, then opened and checked the second envelope contained in the bid of the lone bidder and found that the second envelope contained the prescribed documents and was rated "passed"
- (d) the BAC resolved to declare Datacore Technologies Inc., as the bidder with the Single Calculated Bid with an amount of 998,000.00,
- (e) the BAC directed the TWGs to proceed with the Post-Qualification Evaluation of the Single Calculated Bid;

WHEREAS, in the Post-Qualification Evaluation Conference held via Zoom on November 19, 2024:

(a) the TWG for Financial and Legal Aspects reported that the Single Calculated Bid was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,



- (b) the TWG for Technical Aspect reported that the Single Calculated Bid was responsive to the technical requirements for the project as prescribed in the Bidding Documents,
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the Single Calculated Bid as responsive;

THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- (a) to declare Datacore Technologies Inc., as the bidder with the Single Calculated and Responsive Bid (SCRB), with the bid price of Nine Hundred Ninety Eight Thousand Pesos (998,000.00), and
- (b) to recommend to the President the Award of Contract for the project, project Supply and Delivery of Instructional Accounting Software for the College of Business and Accountancy (APP 2024) to Datacore Technologies Inc.

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Instructional Accounting Software for the College of Business and Accountancy (APP 2024), with an Approved Budget for the Contract (ABC) of ₱ 1,000,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous places in Tarlac State University on September 27, 2024;

WHEREAS, in response to the Invitation to Bid, no prospective bidder participated in the Pre-Bidding Conference held at Tarlac State University BAC Conference Room and webcasted via Zoom on October 8, 2024;

WHEREAS, in the public bidding held at the TSU BAC Conference Room and webcasted via Zoom on October 22, 2024, at 3:00 P.M., only one (1) bidder, namely, Datacore Technologies Inc., participated and tendered a bid for the aforementioned project;

WHEREAS, the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and evaluated the first envelope contained in the bid submitted by the lone bidder, using the non-discretionary "pass/fail" criterion, and found that the first envelope contained all the required documents and was rated "passed";

WHEREAS, the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelope of the lone bidder and found that the envelope of the lone bidder contained the prescribed documents and was rated "passed";

WHEREAS, the BAC with the assistance of the TWGs, proceeded with the evaluation of the financial bid of the lone bidder with the result as summarized below:
