- The Tarlac State University, through Special Budget (SB) 2023 intends to apply the sum of Six Million Nine Hundred Forty One Thousand Eight Hundred Twelve and 50/100 Pesos (₱ 6,941,812.50) to payments under the contract for the project: Refurbishment of Male and Female Toilets at Smith Hall Building.
- Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The Tarlac State University now invites bids for the aforementioned Project. Completion of the Works is required within one hundred eighty (180) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non- discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
