WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Furniture and Fixtures (APP 2024) with an Approved Budget for the Contract (ABC) of ₱ 3,216,281.93 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on September 17, 2024;

WHEREAS, in response to the Invitation to Bid, four (4) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University BAC Conference Room and webcasted via Zoom on September 26, 2024;

WHEREAS, in the public bidding held at the TSU-BAC Conference Room on October 8, 2024, at 2:00 P.M., four (4) bidders, namely, Suntawood Home & Office Inc., Doin Furniture Trading, Vitara Marketing, and Asahi Design Centre Inc., participated and tendered their bids for the aforementioned project;

WHEREAS, the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the four bidders, using the non-discretionary "pass/fail" criterion, and found that the first envelopes of Suntawood Home & Office Inc., Doin Furniture Trading, Vitara Marketing, and Asahi Design Centre Inc., contained all the required documents and were rated "passed";

WHEREAS, the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelopes of the four bidders and found that the envelopes of the four bidders contained the prescribed documents and were rated "passed";

WHEREAS, the BAC with the assistance of the TWGs, proceeded with the evaluation of the financial bids of the four bidders with the results as summarized below:

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Furniture and Fixtures (APP 2024) with an Approved Budget for the Contract (ABC) of ₱ 3,216,281.93 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on September 17, 2024;

WHEREAS, in response to the Invitation to Bid, four (4) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University BAC Conference Room and webcasted via Zoom on September 26, 2024;

WHEREAS, in the public bidding held at the BAC Conference Room on October 8, 2024, at 2:00 P.M.:

- (a) Four bidders, namely, Suntawood Home & Office Inc., Doin Furniture Trading, Vitara Marketing, and Asahi Design Centre Inc., tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the four bidders, using the non-discretionary "pass/fail" criterion, and found the first envelopes of Suntawood Home & Office Inc., Doin Furniture Trading, Vitara Marketing, and Asahi Design Centre Inc., to contain all the required documents and were rated "passed".
- (c) the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelopes of the four bidders and found that the envelopes of the four bidders contained the prescribed documents and were rated "passed";
- (d) the BAC, with the assistance of the TWGs, evaluated and ranked the bids of the four bidders whose first and second envelopes were rated "passed",
- (e) the BAC resolved to declare Vitara Marketing, as the bidder with the Lowest Calculated Bid (LCB) with an aggregate amount of ₱ 2,084,950.00 for the following lot numbers:

Lot No. 1 with the bid price of ₱ 352,950.00, Lot No. 2 with the bid price of ₱ 860,000.00,

Lot No. 3 with the bid price of ₱ 872,000.00,

- (f) to declare Suntawood Home & Office Inc., as the bidder with the Single Calculated Bid (SCB) for Lot No. 4, with the bid price of ₱ 315,000.00,
- (g) the BAC directed the TWGs to proceed with the post-qualification evaluation of the SCB/LCB;

WHEREAS, Vitara Marketing failed to submit the post-qualification requirements for the evaluation of its bid.

WHEREAS, the BAC declare the bid of Vitara Marketing, as disqualified and forfeit its bid security;

WHEREAS, The BAC through the Secretariat sent a Notice of Disqualification to Vitara Marketing on November 6, 2024.

NOW, THEREFORE, based on the foregoing findings, WE, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

(a) to declare Suntawood Home & Office Inc., as the bidder with the 2nd Lowest Calculated Bid (LCB) for Lot Nos. 1 and 3 with an aggregate bid amount of ₱ 1,510,000.00 for the following lot numbers

Lot No. 1 with the bid price of ₱ 455,000.00, Lot No. 3 with the bid price of ₱ 1,055,000.00,

- (b) to declare Doin Furniture Trading, as the bidder with the 2nd Lowest Calculated Bid (LCB) for Lot No. 2 with a bid amount of ₱ 986,080.00 and,
- (c) to direct the TWGs to proceed with the Post–Qualification Evaluation of the LCB and report their findings to the BAC within the prescribed period.

WHEREAS, in the Post-Qualification Evaluation Conference held at the BAC Conference Room and via zoom on November 19, 2024:

- (a) the TWG for the Legal and Financial Aspects reported that the LCB for Lot Nos. 1, 2, 3, and 4 were responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the LCB for Lot No. 1 was responsive, while the LCB for Lot No. 2, 3, and 4 were non-responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the LCB for Lot 1 as responsive, and the LCBs for Lot Nos. 2, 3, and 4 as non-responsive;
- (d) the BAC directed the Secretariat to issue the Notice of Disqualification to Suntawood Home and Office for Lot Nos. 3 and 4,
- (e) the BAC directed the Secretariat to issue the Notice of Disqualification to Doin Furniture for Lot No. 2.
- (f) the BAC directed the TWGs to evaluate the 3rd Lowest Calculated Bid for Lot No. 2, and 3.

WHEREAS, in the Post-Qualification Evaluation Conference at the BAC Conference Room and via zoom on December 27, 2024:

- (a) the TWG for the Legal and Financial Aspects reported that the 3rd LCB for Lot Nos. 2, and 3 was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents.
- (b) the TWG for Technical Aspect reported that the 3rd LCB for Lot No. 2, and 3 was non-responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the 3rd LCB for Lot No. 2 and 3 as non-responsive;
- (d) the BAC directed the Secretariat to issue the Notice of Disqualification to Asahi Design Centre Inc., for Lot Nos. 2 and 3.

THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- (a) to declare Suntawood Home & Office Inc. as the bidder with the Lowest Calculated and Responsive Bid (LCRB) for Lot No. 1, with the bid price of ₱ 455,000.00 and,
- (b) to recommend to the President the Award of Contract for the project Supply and Delivery of Furniture and Fixtures (APP 2024) to Suntawood Home & Office Inc. for Lot No. 1.
- (c) to direct the BAC Secretariat to post the re-bidding for Lot Nos. 2, 3, and 4 for the aforementioned project in accordance with Section 35.3 of the IRR of R. A. 9184.
