WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Fire Extinguishers and Accessories (EPA 2025), with an Approved Budget for the Contract (ABC) of ₱ 1,584,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on October 15, 2024;

WHEREAS, in response to the Invitation to Bid, no prospective bidder participated in the Pre-Bidding Conference held at Tarlac State University BAC Conference Room and webcasted via Zoom on October 23, 2024;

WHEREAS, in the public bidding held at the BAC Conference Room on November 5, 2024, at 3:00 P.M.:

- (a) Two bidders, namely, Valenzuela Safety Device Trading, and Dacrisdeek Enterprises, tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found the first envelopes of Valenzuela Safety Device Trading, and Dacrisdeek Enterprises, to contain all the required documents and were rated "passed",
- (c) the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelopes of the two bidders and found that the envelopes of the two bidders contained the prescribed documents and were rated "passed";
- (d) the BAC, with the assistance of the TWGs, evaluated and ranked the bids of the two bidders whose first and second envelopes were rated "passed",
- (e) the BAC resolved to declare Valenzuela Safety Device Trading, as the bidder with the Lowest Calculated Bid (LCB) with a bid amount of ₱ 999,822.00,
- (f) the BAC directed the TWGs to proceed with the post-qualification evaluation of the LCB;

WHEREAS, in the Post-Qualification Evaluation Conference held at the BAC Conference Room and via zoom on December 27, 2024:

- (a) the TWG for the Legal and Financial Aspects reported that the LCB was nonresponsive to the legal and financial requirements for the project as prescribed in the Bidding Documents.
- (b) the TWG for Technical Aspect reported that the LCB was responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the LCB as non-responsive.

WHEREAS, The BAC through the Secretariat sent a Notice of Disqualification to Valenzuela Safety Device Trading, on January 7, 2025.

WHEREAS. The BAC direct the TWGs to proceed with the Post–Qualification Evaluation of the 2nd LCB and report their findings to the BAC within the prescribed period.

WHEREAS, in the Post-Qualification Evaluation Conference held at the BAC Conference Room and via zoom on February 7, 2025;

- (d) the TWG for the Legal and Financial Aspects reported that the LCB was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents.
- (e) the TWG for Technical Aspect reported that the LCB was responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (f) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the 2nd LCB as responsive.

THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- (a) to declare Dacrisdeek Enterprises, as the bidder with the Lowest Calculated and Responsive Bid (LCRB) with the bid price of ₱ 1,493,850,00 and.
- (b) to recommend to the President the Award of Contract for the project Supply and Delivery of Fire Extinguishers and Accessories (EPA 2025), to Dacrisdeek Enterprises
