WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of College Uniforms (APP 2023) with an Approved Budget for the Contract (ABC) of ₱ 10,575,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on February 10, 2023:

WHEREAS, in response to the Invitation to Bid, five (5) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on February 17, 2023:

WHEREAS, in the public bidding held at the TSU-BC AVR and webcasted via Zoom on March 1, 2023, at 2:00 P.M.:

- (a) Three (3) bidders, namely, England Textiles, Zhujar Manufacturing, Inc., and Woman Fine Clothing, Inc., tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and evaluated the bids of the three bidders and found all the bids to be substantially complying with the eligibility, technical, and financial requirements for the project as prescribed in the Bidding Documents and were rated "passed",
- (c) the BAC evaluated and ranked the financial bids of the three bidders,
- (d) the BAC resolved to declare England Textiles, as the bidder with the Lowest Calculated Bid (LCB) for Lot No. 1 with bid price of ₱ 4,780,000.00,
- (e) the BAC resolved to declare Zhujar Manufacturing, Inc., as the bidder with the LCB for Lot No. 2 with the bid price of ₱ 3,836,160.00,
- (f) the BAC resolved to declare Zhujar Manufacturing, Inc., as the bidder with the LCB for Lot No. 3 with the bid price of ₱ 759,000.00, and
- (g) the BAC directed the TWGs to proceed with the Post-Qualification Evaluation of the LCBs:

- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the LCBs for Lot No. 1, Lot No. 2, and Lot No. 3 as responsive;
