WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Flexible Learning as the New Normal and Emerging Technology for an Improve and Innovative Education with an Approved Budget for the Contract (ABC) of 4,708,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on February 16, 2022;

WHEREAS, in response to the Invitation to Bid, only one (1) prospective bidder participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on February 23, 2022:

WHEREAS, in the public bidding held at the TSU-BC AVR and webcasted via Zoom on March 8, 2022, at 3:00 P.M.:

- (a) one bidder, namely, Hytec Power Inc., tendered a bid for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and evaluated the bid of the lone bidder and found it to be substantially complying with the eligibility, technical, and financial requirements for the project as prescribed in the Bidding Documents and was rated "passed",
- (c) the BAC resolved to declare Hytec Power Inc., as the bidder with the Single Calculated Bid with the amount of 4,705,000.00,
- (d) the BAC directed the TWGs to proceed with the Post-Qualification Evaluation of the and Single Calculated Bid;

WHEREAS, in the Post-Qualification Evaluation Conference held via Zoom on April 13, 2022:

- (a) the TWG for Financial and Legal Aspects reported that the Single Calculated Bid was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the Single Calculated Bid was responsive to the technical requirements for the project as prescribed in the Bidding Documents,
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the Single Calculated Bid as responsive;

THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- (a) to declare Hytec Power Inc., as the bidder with the Single Calculated and Responsive Bid (SCRB), with the bid price of Four Million Seven Hundred Five Thousand Pesos (4,705,000.00), and
- (b) to recommend to the President the Award of Contract for the project, Flexible Learning as the New Normal and Emerging Technology for an Improve and Innovative Education to Hytec Power Inc.,
