WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Equipment for Composting, Rebid with an Approved Budget for the Contract (ABC) of ₱ 1,154,600.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on June 22, 2023;

WHEREAS, in response to the Invitation to Bid, three (3) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on June 29,2023.

WHEREAS, in the public bidding held at the Business Center Audio Visual Room (TSU-BC AVR) on July 11, 2023, at 3:00 P.M.:

- (a) Four bidders, namely, Izzo Industrial Supply, Shock and Awe Industrial Corp., JHT Microenterprises, and Hinoki Global Concepts Inc. tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the four bidders, using the non-discretionary "pass/fail" criterion, and found the first envelopes of Izzo Industrial Supply, Shock and Awe Industrial Corp., JHT Microenterprises, and Hinoki Global Concepts Inc. to contain all the required documents and were rated "passed".
- (c) the BAC, with the assistance of the TWGs, evaluated and ranked the bids of the four bidders whose first envelopes were rated "passed",
- (d) the BAC resolved to declare Izzo Industrial Supply as the bidder with the Lowest Calculated Bid (LCB) with the bid price of ₱ 898,500.40, and
- (e) the BAC directed the TWGs to proceed with the post-qualification evaluation of the LCB;

WHEREAS, in the Post-Qualification Evaluation Conference webcasted via Zoom on August 22, 2023:

(a) the TWG for the Legal and Financial Aspects reported that the LCB was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,

- (b) the TWG for Technical Aspect reported that the LCB was responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the LCB as res ponsive;
