 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelops, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

In consideration for the sum of Four Million Seven Hundred Five Thousand Pesos (Php 4,705,000.00) or such other sums as may be ascertained, Hytec Power, Inc. agrees with the project: Flexible Learning as a New Normal and Emerging Technology for an Improve and Innovative Education in accordance with his/her/its Bid.
- 4. The Tarlac State University agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- 5. This Agreement shall take effect upon date of confirmation of NOTICE TO PROCEED by the Supplier from the Entity. The Contract shall remain in force until all obligations of both parties as contained in this contract have been fully complied with.

The Supplier shall commence execution of the project upon the confirmation of the written Notice to Proceed from the Entity and shall finish and complete the delivery of the project within Ninety (90) calendar days from the date of confirmation unless extended in accordance with the IRR of R.A. 9184.
