APPROVED BUDGET FOR THE CONTRACT (ABC): 6.921,000.00

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Vehicles (EPA 2025) with an Approved Budget for the Contract (ABC) of ₱ 6,921,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous places in Tarlac State University on October 17, 2024:

WHEREAS, in response to the Invitation to Bid, only one (1) prospective bidder participated in the Pre-Bidding Conference held at Tarlac State University BAC Conference Room and webcasted via Zoom on October 30, 2024;

WHEREAS, in the public bidding held at the TSU BAC Conference Room and webcasted via Zoom on November 13, 2024, at 2:00 P.M., two (2) bidders, namely, Areza Motor Sales and Toyota Tarlac City participated and tendered a bid for the aforementioned project;

WHEREAS, the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and evaluated the first envelope contained in the bid submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found that the first envelope of Areza Motor Sales contained all the required documents and was rated "passed", while Toyota Tarlac City was found to be "ineligible" due to the absence of its Net Financial Contracting Capacity;

WHEREAS, the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelope of the lone bidder and found that the envelope of the lone bidder contained the prescribed documents and was rated "passed";

WHEREAS, the BAC with the assistance of the TWGs, proceeded with the evaluation of the financial bid of the lone bidder with the result as summarized below:

- to direct the Technical Working Groups to proceed in the Post-Qualification Evaluation of the SCB and report their findings to the BAC within the prescribed period.

APPROVED BUDGET FOR THE CONTRACT (ABC): 6,921,000.00

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Vehicles (EPA 2025) with an Approved Budget for the Contract (ABC) of ₱ 6,921,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on October 17, 2024;

WHEREAS, in response to the Invitation to Bid, only one (1) prospective bidder participated in the Pre-Bidding Conference held at Tarlac State University BAC Conference Room and webcasted via Zoom on October 30, 2024;

WHEREAS, in the public bidding held at the TSU-BAC Conference Room on November 13, 2024, at 2:00 P.M.:

- (a) Two bidders, namely, Areza Motor Sales, and Toyota Tarlac City, tendered a bid for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelope contained in the bid submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found that the first envelope of Areza Motor Sales, contained all the required documents and was rated "passed", while Toyota Tarlac City was found to be "ineligible" due to the absence of its Net Financial Contracting Capacity form;
- (c) the BAC with the assistance of the TWGs, then opened and checked the second envelope contained in the bid of the lone bidder and found that the second envelope contained the prescribed documents and was rated "passed"
- (d) the BAC resolved to declare Areza Motor Sales, as the bidder with the Single Calculated Bid for the project with an aggregate bid amount of ₱ 6,150,000.00 for the following item numbers.

Lot No. 1 with the bid price of ₱ 2,000,000.00, Lot No. 2 with the bid price of ₱ 4,150,000.00,

(e) the BAC directed the TWGs to proceed with the Post-Qualification Evaluation of the Single Calculated Bid;

WHEREAS, in the Post-Qualification Evaluation Conference held at the TSU-BAC Conference Room on December 4, 2024:

- (a) the TWG for Financial and Legal Aspects reported that the Single Calculated Bid was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the Single Calculated Bid was responsive to the technical requirements for the project as prescribed in the Bidding Documents.
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the Single Calculated Bid as responsive.

THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

(a) to declare Areza Motor Sales, as the bidder with the Single Calculated and Responsive Bid (SCRB), with an aggregate bid amount of ₱ 6.150,000.00 for the following item numbers:

Lot No. 1 with the bid price of ₱ 2,000,000.00, Lot No. 2 with the bid price of \$\mathbb{P} 4,150,000.00.

(b) to recommend to the President the Award of Contract for the project, project Supply and Delivery of Vehicles (EPA 2025) to Areza Motor Sales.
