BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Repair and Repainting of TSU Hotel with an Approved Budget for the Contract (ABC) of ₱ 5,481,446.93 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on February 23, 2024;

WHEREAS, in response to the Invitation to Bid, nine (9) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on March 5, 2024;

WHEREAS, in the public bidding held at the Business Center Audio Visual Room (TSU-BC AVR) on March 19, 2024, at 10:00 A.M.:

- (a) Eight bidders, namely, Ar. Esbi Construction, Slampjam Construction, J3MS Construction, MRRM Trading and Construction, Jayterkiel Builders, Atlasprimus Construction Services, JQG Construction, and Wealthmore Construction and Supply Corporation tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found the first envelopes of Ar. Esbi Construction, Slampjam Construction, J3MS Construction, MRRM Trading and Construction, Jayterkiel Builders, Atlasprimus Construction Services, JQG Construction, and Wealthmore Construction and Supply Corporation to contain all the required documents and were rated "passed".
- (c) the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelopes of the eight bidders and found that the envelopes of Ar. Esbi Construction, Slampjam Construction, J3MS Construction, MRRM Trading and Construction, Jayterkiel Builders, JQG Construction, and Wealthmore Construction and Supply Corporation contained the prescribed documents and were rated "passed"; while the second envelope of Atlasprimus Construction Services was found to be ineligible on the ground that its Financial Bid Form did not conform to the prescribed bid validity period and its performance security.
- (d) the BAC with the assistance of the TWGs, proceeded with the evaluation of the financial bids of the seven bidders, whereas, Wealthmore Construction & Supply Corporation, and JQG Construction declined to accept the award of the contract.

- (e) The BAC declared the bid of Wealthmore Construction & Supply Corporation, and JQG Construction as disqualified and forfeit its bid security;
- (f) the BAC resolved to declare J3MS Construction as the bidder with the Lowest Calculated Bid (LCB) with the bid price of ₱ 4,051,447.94, and
- (g) the BAC directed the TWGs to proceed with the post-qualification evaluation of the LCB;

WHEREAS, in the Post-Qualification Evaluation Conference held at the BAC Conference Room on April 30, 2024:

- (a) the TWG for the Legal and Financial Aspects reported that the 3rd LCB was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the 3rd LCB was non-responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the 3rd LCB as non-responsive;
- (d) the BAC directed the TWGs to proceed with the post-qualification evaluation of the bid of Slampjam Construction, the fourth lowest calculated bid,
- (e) the BAC directed the Secretariat to issue the Notice of Disqualification to J3MS Construction.

WHEREAS, in the Post-Qualification Evaluation Conference held at the BAC Conference Room on May 24, 2024:

- (a) the TWG for the Legal and Financial Aspects reported that the 4th LCB was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the 4th LCB was non-responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the 4th LCB as non-responsive;
- (d) the BAC directed the TWGs to proceed with the post-qualification evaluation of the bid of Ar. Esbi Construction, the fifth lowest calculated bid,
- (e) the BAC directed the Secretariat to issue the Notice of Disqualification to Slampjam Construction.

WHEREAS, in the Post-Qualification Evaluation Conference held at the BAC Conference Room on June 7, 2024:

(a) the TWG for the Legal and Financial Aspects reported that the 5th LCB was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,

- (b) the TWG for Technical Aspect reported that the 5th LCB was responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the 5th LCB as responsive;

THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- (a) to declare Ar. Esbi Construction as the bidder with the Lowest Calculated and Responsive Bid (LCRB) with a bid price of ₱ 4,422,411.07 and
- (b) to recommend to the President the Award of Contract for the project Repair and Repainting of TSU Hotel to Ar. Esbi Construction.

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Repair and Repainting of TSU Hotel with an Approved Budget for the Contract (ABC) of ₱ 5,481,446.93 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on February 23, 2024;

WHEREAS, in response to the Invitation to Bid, nine (9) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on March 5, 2024;

WHEREAS, in the public bidding held at the TSU-BC AVR on March 19, 2024, at 10:00 A.M., eight (8) bidders, namely, Ar. Esbi Construction, Slampjam Construction, J3MS Construction, MRRM Trading and Construction, Jayterkiel Builders, Atlasprimus Construction Services, JQG Construction, and Wealthmore Construction and Supply Corporation participated and tendered their bids for the aforementioned project;

WHEREAS, the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the eight bidders, using the non-discretionary "pass/fail" criterion, and found that the first envelopes of Ar. Esbi Construction, Slampjam Construction, J3MS Construction, MRRM Trading and Construction, Jayterkiel Builders, Atlasprimus Construction Services, JQG Construction, and Wealthmore Construction and Supply Corporation contained all the required documents and were rated "passed";

- (a) to declare the bid of Wealthmore Construction & Supply Corporation as disqualified and forfeit its bid security;
- (b) to declare the bid of JQG Construction as disqualified and forfeit its bid security;
- (c) to declare J3MS Construction as the bidder with the Lowest Calculated Bid (LCB) for the project with the bid price of ₱ 4,051,447.94 and
- (d) to direct the TWGs to proceed with the Post–Qualification Evaluation of the LCB and report their findings to the BAC within the prescribed period.
