# BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB)

APPROVED BUDGET FOR THE CONTRACT (ABC): ₱ 5,850,000.00

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of TSU Lambal with an Approved Budget for the Contract (ABC) of ₱ 5,850,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on May 6,2022;

WHEREAS, in response to the Invitation to Bid, two (2) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) on May 13, 2022;

WHEREAS, in the public bidding held at the TSU-BC AVR on May 25, 2022, at 2:00 P.M.:

- (a) two (2) bidders, namely, England Textiles and Zhujar Manufacturing Inc., tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and evaluated the bids of the two bidders and found the bids to be substantially complying with the eligibility, technical, and financial requirements for the project as prescribed in the Bidding Documents and were rated "passed",
- (c) the BAC evaluated and ranked the financial bids of the two bidders,
- (d) the BAC resolved to declare Zhujar Manufacturing Inc., as the bidder with the Lowest Calculated Bid with the bid price of ₱ 5,704,500.00 and,
- (e) the BAC directed the TWGs to proceed with the Post-Qualification Evaluation of the LCB:

WHEREAS, in the Post-Qualification Evaluation Conference held on July 7, 2022:

- (a) The TWG for Financial and Legal Aspects reported that the LCB was non-responsive to the legal and financial requirements for the project on the ground that the increase in the authorized capital claimed by the firm in its amended Articles of Incorporation was not duly reported in its audited financial statement.
- (b) The TWG for Technical Aspect reported that the LCB was responsive to the technical requirements for the project,

- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the LCB as non-responsive and post-disqualified,
- (d) the BAC directed the TWGs to proceed with the post-qualification evaluation of the bid of England Textiles, the bidder with the second Lowest Calculated Bid, and
- (e) the BAC directed the Secretariat to issue the Notice of Disqualification to Zhujar Manufacturing, Inc.;

WHEREAS, in the Post-Qualification Evaluation Conference held on July 28, 2022:

- (a) the TWG for the Financial and Legal Aspects reported that the bid of England Textiles was responsive to the legal and financial requirements for the project,
- (b) the TWG for Technical Aspect reported that the bid of England Textiles was responsive to the technical requirements for the project, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the bid of England Textiles as responsive;

THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- (a) to declare England Textiles, as the bidder with the Lowest Calculated and Responsive Bid (LCRB) for the project Supply and Delivery of TSU Lambal with the bid price of ₱ 5,850,000.00 and
- (b) to recommend to the President the Award of Contract for the project Supply and Delivery of TSU Lambal to England Textiles.
